ARTICLE XI – OFFICERS AND DIRECTORS

Section 1. Officers. The elected officers of the Association shall be: The Chairman elect shall be elected for a term of one year and shall automatically succeed to chairman following his/her term as chairman. All officers shall take office on October 1st and shall serve for one year or until their successor is elected except the treasurer, who shall serve for a two- year term. The secretary and treasurer may be the same person. He/She shall be elected for two (2) years and eligible to be elected another term. (Adopted by GJARA)

- (a) The Chair Elect shall serve in the absence of the President and shall automatically become President in the case of a vacancy between elections.
- (b) To be eligible to serve as an Officer, the Member must have at one time served as a Director or held an Office, appointive or elective.
